

## Amendment to Existing Agreements (GDPR/EU DPA)

This Amendment to Existing Agreement(s) ("Amendment") is made and entered into as of the <u>date of Epicor's acceptance of Customer's completed assessment titled "Data Interchange-Amendment to Incorporate Revised EU SCCs" through OneTrust (Effective Date) by and between Data Interchange Limited and its international affiliates (now an Epicor Software Corporation group company) (together and/or individually "Data Interchange") and the undersigned Customer ("Customer"). Each a "Party" and together the "Parties".</u>

## RECITALS

- A. Customer and Data Interchange Limited are Parties to Data Interchange's General terms of Business (as supplemented by a Data Processing Schedule), the terms and conditions of which are available at <a href="https://datainterchange.com/wp-content/uploads/2021/03/General-Terms-2018v2.pdf">https://datainterchange.com/wp-content/uploads/2021/03/General-Terms-2018v2.pdf</a> and/or another similar existing software licence agreement (collectively and/or individually the "Existing Agreement") pertaining to Customer's license of Software and/or SaaS Services from Data Interchange and/or its affiliates as well as the provision, by Data Interchange, of support, professional, and/or other Subscription Services to Customer.
- B. Data Interchange and Customer desire to amend the Existing Agreement(s) (in particular the Data Processing Schedule(s) to incorporate the revised EU Standard Contractual Clauses in force on and from 27 June 2021), on the terms provided herein below.

**NOW THEREFORE**, in consideration of the above recitals (which shall form part of this Amendment and the Existing Agreement) and the mutual covenants and conditions contained below, Data Interchange and Customer hereby agree as follows:

1. The following term shall be inserted into the Existing Agreement(s) in the style content and format as follows:

European General Data Protection Regulation (EU GDPR). If and to the extent Data Interchange and/or Epicor (as successor in interest and title to Data Interchange) processes "Personal Data" as defined under the EU General Data Protection Regulation for Customer, Data Interchange (and/or Epicor as successor in interest in interest and title to Data Interchange) agrees to comply with (and be bound by) the EU version of the Data Processing Addendum titled "Data Interchange EU Data Processing Addendum" ("Data Interchange EU Data Processing Addendum") available for download at <a href="https://www.epicor.com/en-us/company/data-privacy-addenda/">https://www.epicor.com/en-us/company/data-privacy-addenda/</a> the terms and conditions of which are hereby incorporated by reference. In the event of any conflict between the Existing Agreement(s) and the Data Interchange EU Data Processing Addendum, the Data Interchange EU Data Processing Addendum shall control.

Except as provided herein, the terms and conditions of the Existing Agreement(s) (including any Data Processing Schedules) shall remain in full force and effect. All terms not defined in this Amendment shall have the meanings ascribed to them in the Existing Agreement(s).
